EUROPEAN BOOK PUBLISHING STATISTICS 2004

Executive Summary

These figures represent revenues of publishers from the sale of books but not the total market of books (margin of the booksellers or other retailers), they also don't account for revenues in terms of selling rights for translation, audiovisual adaptation, etc.

The annual sales revenue of book publishers within the EU and the EEA is approximately € 22.268 million, according to a survey conducted by the Federation of European Publishers (FEP). No comparison can be made with the previous survey taken two years ago since the perimeter has changed and includes 7 new EU Member States. The survey is based on reports and estimates from the national book publishing associations principally for the year 2004.

FEP represents 25 national associations of book publishers from the European Union and of the European Economic Area Member States (see page 2).

Sales of educational books at all levels, including dictionaries, encyclopedia, reference and professional books amount to €9,589 million, or 43.3% of the total. Sales of consumer (trade) books including books for children, amount to €12,558 million, or 56.7% of the total. The attached table shows the breakdown between various categories.

An estimated 78% of all sales of European publishers were to bookshops and wholesalers; 8% are sold through Book Clubs and 14% directly to the customer.

A total of 620,133 new books or new editions were issued by publishers. 17 members gave information on the number of titles in print, but as they represented all the major publishing nations, it can be assumed confidently that the number of titles available from publishers throughout the EU is not less than 3,959,000. Those countries reporting the largest title availability are: UK (1,125,000), Germany (1,000,000), France (498,000), Italy (491,000) and Spain (276,000).

The report reveals that a total of approximately 123,000 people are employed full time in book publishing.

Publishing in the German language accounted for €4.914 million, followed by English at €4.685. French (€3,130 million) and Spanish (€2.881 million) were the next most published languages followed by Italian (€1.993 million).
